Liechtenstein,
which until now was applying the standards coming
from the OMS recommendations (M. Repacholi), from ICNIRP
and repeated under the normative reference 1999/519/CE
that means the same as those opposable in France coming from the scandalous
[2002-775 decree](#) supported particularly by AFSSET (Health Authority France)
(41 V/m for 900 MHz, 58 V/m for 1800 MHz and 61 V/m for UMTS)
is just reducing these limits for ...
90 % or in other words to near **10 times** !

Essentially however the positive projection
is the 4th paragraph of the 34th article
of the new law that anticipates the transition to a limit of
0.6V/m,
or a 100 times lower than the actual peak limits of maximum power in 2012
for all interference merged sources,
this according to temporary recommendations of
BioInitiative Scientific Consortium report.

Next-up Organisation considers that in France those who guaranty or oppose the actual
regular limits in artificial microwave hyper frequencies for what concerns the radiation of
the population with mobile phone apparatus and installations
(relay antennas, hertz repeaters, ...)
in 900 MHz, 1800 MHz and 2150 MHz (UMTS) frequencies and above in GHz,
with unreal regulation limits in particular of 61 V/m
are either betrayers, irresponsible, idiots or acting the fool who, we have no doubt about
it, will have to explain themselves in Court of justice.
If anyone does not agree with this public sanitary appreciation,
including Health Ministers, we are pleased.

[0,6 V/m = 0,1 \$\mu\$ W/cm²](#)

That is to say a radiation power reduction of 10 000 times less !

- EXTRACT -

Hier after the Landtag decision

I agree :

I. General Principles and dispositions.

A. Principles

Article 1

Aim :

- 1) The present law's aim is human, animals and plants as well as their life community and their habitats against pollution or the need to protect natural resources, particularly the biologic diversity, the ground fertility, the water and air quality, those in a perfect manner.
- 2) The senses of the foresight are physical, against the harmful or the awkward that must be limited as soon as possible.
- 3) This law serves to implement the enumerated to the annexe of EEE legislation.

Article 2

Principle : "Polluters are to pay"

Those who get in the field of the present law measures are condemned to be ordered to pay the costs for that.

Article 33

Fiche de site de Station de Base

Chart of Base Station Site :

- 1) The owner of an installation must conform to the transmitting limits fixed by the present law or regulation.
The transmission limits are fixed by the Environment Protection Office.
A Base Station Site must be bound to these data, so are concerned the establishment of an installation, the existing base station replacement or its modification. The electrical supply installations are excluded.
- 2) The government is fixing by regulation the Base Station's Chart requirements.
For what concerns the mobile phone transmitters and Wi Fi local Loops

Article 34

The limit values for installation

- 1) For what concerns the transmitting base stations in network of cellular phone and transmitting stations as well as the local Wi Fi loops or an equivalent body with a radiation power of at least of 6 watts, the installation limit values will be according to paragraph 2 and 4.

These dispositions are not applicable to the following equipments: Wi Fi "Polycom" security system and other radio nets for security and assistance organisations.

- 2) The efficient power limit values of the electrical field value transmitted is :
 - a) For what concerns only the installations in the frequency band from 900 MHz, the limit is set to 4.0 V/m;
 - b) For what concerns only the installations in the frequency band of 1800 MHz or greater (UMTS), the limit is set to 6.0 V/m;
 - c) For what concerns all the other transmitting installation in the field of all frequency band as §a) and also as § b), the limit is set to : 5.0 V/m.
- 3) Those limits are fixed for an operation maximum measuring (peak) of the transmitters depending of maximum traffic.
- 4) The holder of Base Station Sites are due to take all appropriated arrangements in order to technically keep the electromagnetic field as low as possible in order to have the regulation reduction to be feasible and reached by the end of 2012, which will be an real mean of electromagnetic fields limited to 0.6 V/m.
- 5) The government allows for additives at this regulation.

Article 97

To come into effect

The present law comes into effect,
subject to referendum, on September 1, 2008 ;
otherwise the day of its communication.
